セミナー概要

Peer review is a key feature of academic publishing. For early career researchers, negative reviews undermine confidence and threaten your success – but there is always pressure to publish – or perish. In previous seminars, Professor Howitt has explored the task of writing. His third workshop looks at reviewing and responding to reviews. Using real life negative reviews, Professor Howitt will encourage participants to identify strategies to respond to hostile reviews, inconsistent reviews, and editorial questions. He will explore guidelines for reviewers, resources to improve participants' own reviews and responses, and tools to document peer review activities as part of your resumé. Participants are encouraged to provide a de-identified copy of their own worst reviews for discussion in the workshop. Please forward them to kyodo-sankaku@adm.nagoya-u.ac.jp by September 19. 講師紹介

Richie Howitt received the Australian Award for University Teaching (Social Science) in 1999 and Macquarie University's Vice-Chancellors Award for Higher Degree Research Supervision in 2013. Having mentored early career staff in geography, law, anthropology, sociology and biology, he has developed sound strategies to develop good writing strategies. He has 25 years' experience in teaching, research and academic governance. His research addresses Indigenous rights and community well-being in landscapes of difference and diversity. He advocates deep integration of social, environmental and economic dimensions of justice into local governance systems for just and sustainable outcomes and has been working as Director of Macquarie's innovative partnership relationship with Ryde City Council in Sydney for several years. He is an elected member of his University's governing Council and provides institutional leadership across disciplines.
